



## LOCAL BOARD RESOLUTION

**WHEREAF:** The Mayors Directors Board of the Manatí/Dorado Local Workforce Development Area, in an Extraordinary Meeting held on March 15, 2021, determined that all employees in the Trust Service who work in the Central Consortium and in the Local Board should have to submit their resignation letters on or before March 26, 2021.

**WHEREAF:** Public Law 113-128 of July 22, 2014, Workforce Innovation and Opportunity Act (WIOA), in section 107 (f) (1) (2), states the following:

“ ...

(f) STAFF.---

(1) IN GENERAL.---The local board may hire a director and other staff to assist in carrying out the functions described in subsection (d) using funds available under sections 128(b) and 133(b) as described in section 128(b)(4).

(2) QUALIFICATIONS.---The local board shall establish and apply a set of objective qualifications for the position of director, that ensures that the individual selected has the requisite knowledge, skills, and abilities, to meet identified benchmarks and to assist in effectively carrying out the functions of the local board.

...”

**WHEREAF:** The Collaboration Agreement - Mayors Directors Board and Local Workforce Development Board, formalized on August 9, 2019, in its Article II, subsection 21 states the following:

"Article II: Responsibilities of the Local Workforce Development Board

...21. It will be the Local Board's responsibility to select a director and staff to perform the functions described in section 107 (d) of the WIOA Act, for the use of funds available under Sections 128 (b) and 133 (b), as per it is described in section 128 (b) (4) of the WIOA Act. The selection of this staff must be in accordance with the provisions of the Classification and Remuneration Plan of the Career and Trust Service of the Manatí/Dorado Local Workforce Development Area and regulations that apply in accordance with the provisions of Law 81-1991, as amended. The recruitment process and other personnel transactions will be carried out using as a guide the procedures established by both Boards ... "

**THEREFORE:** **The Local Workforce Development Board establishes the following:**

**1ST SECTION:** The Manatí/Dorado Local Workforce Development Board, in an Extraordinary Meeting held on March 29, 2021, strongly rejects the Mayors Directors Board's determination, your request shall not be taken into consideration and we do not authorize the administrative staff of the Local Board to submit resignations to their position in the Trust Service, understand: Executive Officer of the Local Board - Aileen Álamo Santana, Coordinator of the Local Board - Luis Gabriel Rosario Álamo, Monitor/Auditor - Patricia Rodríguez González, and Monitor/Auditor - Jayne Nieves Melecio.

**2ND SECTION:** The members here present authorize the President of the Local Board, Mr. Erasmo Rafael Lamberty Sánchez, to sign this Resolution on our behalf.
