PUBLIC POLICY FOR ADOPTING THE SERVICE PRIORITY PUBLIC POLICY OF THE ADULT PROGRAM OF TITLE I OF THE WORKFORCE INNOVATION AND OPPORTUNITY ACT (WIOA)

## I. Purpose:

1. To provide guidance regarding serving priority populations under the WIOA Title I Adult Program.

2. To mandate that Local Boards, adopt public policies and procedures to ensure that 75% of individuals receiving individualized career and training services under the Adult Program are part of at least one of the priority groups defined by the WIOA.

3. To establish a subsequent priority level for:

- a. Individuals with disabilities.
- b. Individuals involved in the justice system.
- c. Single parents.

## II. Legal Basis:

Referencing WIOA, various TEGLs, 20 C.F.R. parts, and procedures for WIOA violation determinations and sanctions.

#### III. Public Policy:

- The Manati/Dorado Local Labor Development Area is committed to leading in labor market changes and ensuring the exclusive rights of participants in the Youth, Adult, and Dislocated Worker Programs under WIOA Title I.
