PUBLIC POLICY TO ADOPT THE <u>PUBLIC POLICY NO. WIOA-PP-01-2025</u>, <u>SELF-ATTESTATION</u>, DEVELOPED BY STATE WORKFORCE DEVELOPMENT BOARD TO DOCUMENT THE ELIGIBILITY OF PARTICIPANTS IN THE PROGRAMS UNDER THE WORKFORCE INNOVATION AND OPPORTUNITY ACT (WIOA) OF THE MANATI-DORADO LOCAL WORKFORCE DEVELOPMENT AREA.

# I. PURPOSE

The purpose of the Public Policy is to adopt the Public Policy No. WIOA-PP-01-2025, Self-Attestation, developed by the State Workforce Development Board.

To establish guidelines for documenting participants' eligibility for programs under the Workforce Innovation and Opportunity Act (WIOA) by means of a written or electronic statement signed by the individual. This public policy will facilitate access to services when obtaining supporting documentation is difficult to obtain, ensuring their proper use and in compliance with federal, state, and local requirements. Included is Public *Policy Self-Declaration Form No. WIOA-11-2025 to use our Manatí-Dorado Local Workforce Development Area*.
