**SUBJECT: TO REPEAL PUBLIC POLICY NUMBER WIOA-04-2020 FOR PUBLICITY, TRANSPARENCY, OPENNESS AND DISCLOSURE RELATED TO THE ACTIVITIES OF THE MANATÍ/DORADO WORKFORCE DEVELOPMENT BOARD AND ADOPT PUBLIC POLICY CREATED BY THE STATE WORKFORCE DEVELOPMENT BOARD DDEC-WIOA-01-2021.**

**REFERENCE: DDEC-WIOA-01-2021 - TRANSPARENCY AND DISCLOSURE REQUIREMENT (Sunshine Provision) FOR LOCAL BOARD ACTIVITIES UNDER THE WORKFORCE OPPORTUNITY AND INNOVATION ACT (WIOA)**

According to a review conducted by the Monitoring and Compliance Division of the Department of Economic Development and Commerce (DDEC), it is recommended that the Manatí/Dorado Local Workforce Development Board make amendments and/or repeal and adopt State Public Policies that improve the efficiency of services to the population of the Local Areas.

Accordingly, Public Policy **WIOA-04-2020** of April 23, 2020, entitled *Public Policy for Publicity, Transparency, Openness and Disclosure Related to the Activities of the Manatí/Dorado Workforce Development Board* is hereby repealed. In turn, with the responsibility that falls on the Manatí/Dorado Local Workforce Development Area and understanding that it is the best way to operate and comply with the established statutes, the Local Area abides by the Public Policy **DDEC-WIOA-01-2021**, promulgated by the State Workforce Development Board and titled *Transparency and Disclosure Requirement (Sunshine Provision) of Local Board Activities under the Workforce Innovation and Opportunity Act (WIOA)*.

## **PUBLIC POLICY DETERMINATION**

When public policies enacted by the Workforce Development Program, or directly from the Federal Government, represent a need to amend, repeal or adopt public policies, the Local Workforce Development Board, with the quorum established according to the Internal Regulations, shall evaluate and express its opinion.

## **REQUIRED ACTION**

The Executive Officer of the Local Board shall be responsible for informing the governing body of the determination of public policy.

## **APPROVAL AND EFFECTIVENESS**

The approval and effectiveness of the *Public Policy on Transparency and Disclosure Requirements (Sunshine Provision) for Local Board Activities under the Workforce Innovation and Opportunity Act (WIOA)* shall be effective upon approval by the members of the Local Workforce Development Board and the Board of Directors of Mayors of the Manatí/Dorado Local Workforce Development Area.
